

Memorandum of Understanding

Between

Bosco College of Teacher Education,

situated at Kuda Village, Dimapur And

ANMA Integrated Development Association (AIDA)

The Memorandum of Understanding (**hereafter referred to as MoU**) is entered between. **Bosco College of Teacher Education** situated at Kuda Village, Nagarjan-A, and ANMA Integrated Development Association (**hereinafter AIDA**), located at Don Bosco Campus, N.N. Gaon, River Belt Colony, Dimapur, Nagaland on the ...15th day of MAY 2023. Both **Bosco College of Teacher Education** and AIDA shall also be collectively referred to as **parties**. The areas of cooperation may include, subject to mutual consent, any desirable and feasible activity that would further the goals of both parties.

1. Objectives

The primary objective of the MoU is to create a means for collaboration between **Bosco College of Teacher Education** and **AIDA** in the following areas:

1. Training of students in skills enhancement programme.
2. To apply for Educational projects and rout through AIDA especially foreign projects
3. To collaborate for research and survey programmes.
4. To collaborate with **Child Friendly Dimapur** for awareness programmes.
5. To collaborate with Don Bosco Job Placement Network for career couselfing and placement.
6. To mutually access quality learning, community projects and innovations in diverse fields of education including social work.
7. To conduct Seminars and Workshops collaboratively.
8. To organize awareness programmes and conferences in field of mutual interest.
9. To promote environmental concerns through eco-clubs

2. Coordination

Both parties will designate persons who will have responsibility for coordination and implementation of this agreement.

3. Confidentiality

In the event that either **Bosco College of Teacher Education** or **AIDA** wishes to disclose any data and/or information supplied in or resulted from the implementation of this MoU, the disclosing party shall have prior written consent from the other party.



4. Duration of the MoU

This MoU, shall be signed for the next ten years (renewable every decade) unless by mutual written consent of the **parties**, decide to terminate the agreement, for reasons like breach of trust by one party, infamy to the institution etc. Clauses to the objectives can be modified with mutual consent, review and information annually.

Either party may terminate the MoU by giving written notice to the other party six months in advance. Once terminated, neither party will be responsible for any losses, financial or otherwise, which the other party may suffer. However, both **parties** will ensure that all activities in progress are allowed to complete successfully.

5. Resolution of Disputes and Governing Law

In the event of any unforeseen issues or matters not covered herein or any controversy, dispute or difference arising out of or in connection with this MOU, the same shall be resolved amicably by both the parties.

The MoU is signed subject to approval of the respective administrative bodies. By signing below, the parties, acting duly by their authorized officers, have caused this MoU to be executed, effective as of the date and year first written above.




