**MEMORANDUM OF UNDERSTANDING FOR ACADEMIC COLLABORATION  
BETWEEN  
BOSCO COLLEGE OF TEACHER EDUCATION  
AND  
NORTH EAST INSTITUTE OF SOCIAL SCIENCES AND RESEARCH (NEISSR)**

The MEMORANDUM OF UNDERSTANDING (hereafter called as MOU) is entered between BOSCO COLLEGE OF TEACHER EDUCATION, situated at Kuda Village, Nagarjan-A, Dimapur, Nagaland -AND- NORTH EAST INSTITUTE OF SOCIAL SCIENCES AND RESEARCH (NEISSR) located at 7<sup>th</sup> Mile, Peace Centre, Chumoukedima, Nagaland on the 10<sup>th</sup> day of February, 2019 for academic cooperation in the areas of mutual interest, and in accordance with terms and conditions set forth.

The aforesaid institutions/organizations are here in after referred to individually as "PARTY" and collectively as "PARTIES".

**1. OBJECTIVES**

The goal is to foster collaboration and facilitate advancement of knowledge through interactions. The Parties agree:

- 1) To organize joint workshops, seminars, and conferences for the professional development of students and faculty.
- 2) To facilitate the sharing of resources, including libraries, research facilities, and technological tools, to enhance the academic and operational capacities of both the Teacher Education College and MSW College.

3) To jointly develop and implement interdisciplinary educational programs and curriculum that integrate the fields of education and social work, aimed at enhancing the academic and professional competencies of students.

The **Parties** further agree that detailed terms and conditions that guide each activity identified above will be separately determined and agreed upon by the two **Parties**. These terms shall include a technical description of the proposed activity, financial arrangements, and person(s) responsible for its implementation, etc.

## 2. COORDINATION

Both **parties** will designate persons who will have responsibility for coordination and implementation of this agreement.

## 3. FINANCIAL ARRANGEMENTS

Any cooperation under this **MOU** is subject to the availability of funding sources and approval by relevant authorities.

## 4. LEGAL FEES

Each **Party** is to pay its own legal costs and disbursements incidental to the preparation, completion and signing of the Agreement.

## 5. STAMP DUTY

Each **Party** shall equally pay the stamp duty or other levy or charges (including any penalties or fines) which payable on this document or in respect of any transaction referred to in this document and any documents which are executed in accordance with the provisions of this document to effect those transactions.

## 6. ASSIGNMENT

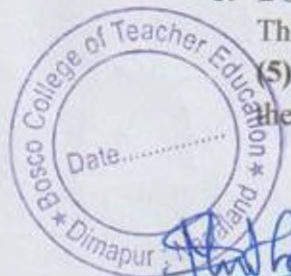
Neither **Party** may assign, in whole or in part, the benefits or obligations of the Agreement to any person other than an affiliate without the prior written consent of the other **Party**.

## 7. CONFIDENTIALITY

In the event that either **Party** wishes to disclose any data and/or information supplied in or resulted from the implementation of this **MOU**, the disclosing **Party** shall have prior written consent from the other **Party**.

## 8. DURATION OF THE MOU

This **MOU**, unless extended by mutual written consent of the **Parties**, shall expire in five (5) years after the effective date specified in the opening paragraph and may be continued hereafter after suitable review and agreement.
