

Memorandum of Understanding for Academic Collaboration

Between

Bosco College of Teacher Education

And

St. Mary's Higher Secondary School

The **Memorandum of Understanding** (hereafter called as **MoU**) is entered between **Bosco College of Teacher Education**, situated at **Kuda A, Dimapur** and **St. Mary's Higher Secondary School**, located at **Padumpukhuri, Dimapur, Nagaland** on the 6th day of February, 2019 for academic cooperation in the areas of mutual interest, and in accordance with terms and conditions set forth.

The aforesaid institutions/organisations are here in after referred to individually as **party** and collectively as **parties**.

1. Objectives

The goal is to foster collaboration and facilitate advancement of knowledge through interactions.

The **parties** agree:

- 1) To enable the student-teachers to develop the necessary teaching skills through the practice teaching.
- 2) To develop classroom management skills among the student-teachers
- 3) To benefit the school children through the services rendered by the student-teachers through the school internship programme.

The **parties** further agree that detailed terms and conditions that guide each activity identified above will be separately determined and agreed upon by the two **parties**. These terms shall include a technical description of the proposed activity, financial arrangements, and person(s) responsible for its implementation, etc.

2. Coordination

Both **parties** will designate persons who will have responsibility for coordination and implementation of this agreement.

3. Financial Arrangements

Any cooperation under this MoU is subject to the availability of funding sources and approval by relevant authorities.


4. Legal Fees


Each **Party** is to pay its own legal costs and disbursements incidental to the preparation, completion and signing of the Agreement.

5. Stamp Duty

Each **Party** shall equally pay the stamp duty or other levy or charge (including any penalties or fines) which payable on this document or in respect of any transaction referred to in this document and any documents which are executed in accordance with the provisions of this document to effect those transactions.

Neither **Party** may assign, in whole or in part, the benefits or obligations of the Agreement to any person other than an affiliate without the prior written consent of the other **Party**.

7. Confidentiality

In the event that either **party** wishes to disclose any data and/or information supplied in or resulted from the implementation of this MoU, the disclosing **party** shall have prior written consent from the other **party**.

8. Duration of the MoU

This MoU, unless extended by mutual written consent of the **parties**, shall expire in **FIVE Years** after the effective date specified in the opening paragraph and may be continued thereafter after suitable review and agreement.

Either institution may terminate the MoU by giving written notice to the other institution six months in advance. Once terminated, neither **parties** will be responsible for any losses, financial or otherwise, which the other institutions may suffer. However, both **parties** will ensure that all activities in progress are allowed to complete successfully.

The MoU is signed subject to approval of the respective academic/administrative bodies. By signing below, the institutes, acting duly by their authorised officers, have caused this MoU to be executed, effective as of the date and year first written above.
